The **Immunisation Team** is visiting on **9 October and 11 December** to deliver Influenza (flu) vaccinations via nasal spray.

Please complete the e-consent form for your young person before midday on 4 October by visiting:

www.surreyimmunisations.co.uk and entering our school unique code SR143903 If you do not want your young person to receive the vaccine, then please fill in the 'No' box.

If you do not want your young person to receive the nasal spray vaccine on the **basis of porcine** gelatine, please fill in the 'No' box indicating this, and you will be given the opportunity to consent for an alternative vaccination. This alternative vaccination is delivered by injection into the arm (intramuscularly) and does not contain any porcine DNA agents.

An automated email will be sent to you on completion of the e-consent form from Cinnamon Digital Applications (who host the website). If you do not receive this, please check in your junk email, or contact the Immunisation team on the email above.
